MR. RENO LEATHER 2021 CONTESTANT REQUIREMENTS:

- > MUST BE 21 YEARS OF AGE OR OLDER BY FEBRUARY 11TH, 2023
- > MUST HAVE A DEMONSTRATED INTEREST IN LEATHER, BDSM AND/OR FETISHES AS DETERMINED BY THE CONTEST PRODUCER(S)
- > MUST AGREE TO APPEAR ON STAGE WEARING APPROPRIATE LEATHER AND FETISH GEAR AND THEME FOR EACH OF THE ON-STAGE CONTEST ROUNDS.
- > MUST HAVE ADEQUATE TRANSPORTATION TO AND FROM CONTEST EVENTS.
- > THE ENTRY FOR MR. RENO LEATHER IS \$20. THIS IS EXPECTED TO BE PAID BY THE CONTESTANT/SPONSOR.

MR. RENO LEATHER JUDGING METHOD

MR. RENO LEATHER CONTESTANTS SHALL BE SCORED BY A PANEL OF JUDGES USING A SCORING SYSTEM, TO BE DETERMINED BY THE CONTEST PRODUCER(S), IN THE CATEGORIES AND POINTS BELOW:

CASUAL CRUISE/BAR WEAR ROUND:

MAXIMUM 30 POINTS

EACH CONTESTANT SHALL APPEAR ON STAGE WITH WHAT THEY INTERPRET AS CRUISE OR BAR WEAR ATTIRE. THIS IS THE FIRST INTRODUCTION OF THE CONTESTANT ON STAGE. THE CONTESTANT WILL INTRODUCE THEMSELVES, GIVE A BRIEF SUMMARY OF EXPERIENCES & INTERESTS SUCH AS FAVORITE KINKS, HANKEY COLOR FLAG, ETC. THEY WILL THEN BE ASKED A SERIOUS QUESTION BY A JUDGE. STAGE PRESENCE WILL BE JUDGED INCLUDING CONFIDENCE, PERSONA, VERBAL AND NON-VERBAL INTERACTION WITH THE EMCEE, JUDGES AND AUDIENCE.

PHYSIQUE/JOCKSTRAP ROUND:

MAXIMUM 30 POINTS

EACH CONTESTANT SHALL APPEAR ON STAGE IN BODY-REVEALING ATTIRE WHICH EMPHASIZES THEIR BEST PHYSICAL QUALITIES. THE CONTESTANT WILL BE ASKED A HUMOROUS QUESTION WHICH THEY WILL BE REQUIRED TO ANSWER. THE CONTESTANT WILL BE JUDGED NOT ONLY ON HIS PHYSICAL PRESENTATION BUT ALSO ON HOW THEY ANSWER THE IMPROMPTU QUESTION.

FORMAL LEATHER IMAGE & SPEECH ROUND:

MAXIMUM 30 POINTS

EACH CONTESTANT WILL APPEAR ON STAGE TO INTRODUCE THEMSELF TO THE AUDIENCE AND BRIEFLY DESCRIBE THEIR BACKGROUND OR INTEREST IN THE LEATHER COMMUNITY, WHILE WEARING THE ATTIRE THAT BEST REPRESENTS THEIR IMAGE OF A LEATHERMAN. THE CONTESTANT WILL HAVE 90 SECONDS TO ADDRESS THE JUDGES AND AUDIENCE ON ANY TOPIC OF THEIR CHOOSING. THE CONTESTANT WILL BE JUDGED ON THEIR FORMAL LEATHER PRESENTATION AND THEIR PUBLIC SPEAKING ABILITY WHEN ADDRESSING THE CROWD.

VOTING

MAXIMUM 10 POINTS

SPECTATORS WILL BE GIVEN A TICKET TO VOTE FOR THEIR FAVORITE CONTESTANT WHEN THEY PAY THEIR DONATION ENTRY. EXTRA TICKETS WILL BE AVAILABLE FOR PURCHASE. THE HIGHEST VOTED CONTESTANT WILL EARN AN EXTRA 10 POINTS TOWARDS THEIR FINAL SCORE AS THE 2ND HIGHEST WILL EARN AN EXTRA 5. VOTING WILL END AT THE END OF THE PHYSIQUE/JOCKSTRAP ROUND.
